The undersigned hereby claims exemption on the purchase of tangible personal property from: Wolff Bros. Supply, Inc.

under this certificate and certifies that this claim is based upon the purchaser's proposed use of the item purchased, the activity of the purchaser, or both, as shown hereon:

- For resale in the form in which the same is, or is to be, received.
- For use or consumption:
 - Directly in making retail sales. (5)
 - As a material or part for incorporation into personal property to be produced for sale by manufacturing, assembling, processing, or refining. (7)
 - Directly in production of personal property for sale by manufacturing, processing, refining, assembling, or mining. (1) (7)
 - Directly in the production of personal property for use or consumption directly in the production of personal property for sale by manufacturing, processing, refining or assembling. (7)
 - Directly in the production of personal property for sale by farming, agriculture, horticulture or floriculture. (2)
 - Directly in the production of crude oil or natural gas. (3)
 - Directly in the rendition of a public utility service. (6)
 - Directly in commercial fishing.
 - Directly in the production of magazines distributed as controlled circulation publications. (8)
 - In the production and preparation in suitable condition for market and sale of printed, imprinted, overprinted, lithographic, multilithic, blue-printed, photostatic, or reproductions of written or graphic matter.
 - Directly in the preparation of eggs for sale, including cleaning, sanitizing, preserving, grading, and sorting of eggs and the classifying of eggs by size.
 - Directly in the transformation or conversion of raw coal into coke.
 - Primarily in the process of reclamation of strip-mined land as required by Chapters 1513 and 1514 of the revised code.
- To hold the thing transferred as security for performance of an obligation of the vendor.
- To sell, hold, use or consume the article as evidence of a contract of insurance.
- A sale:
 - To any government agency (federal, state, county, municipality).
 - To a church.
 - To a nonprofit organization operated exclusively for charitable purposes in this state. (4)
 - Of a ship or vessel for use principally in interstate or foreign commerce, or of repairs, alterations, fuels and lubricants therefor.
- A sale of packages or of materials and parts therefor, or of machinery, equipment, and materials for use in packaging personal property produced for sale or sold at retail, to a person engaged in:
 - Production of personal property for sale by manufacturing, assembling, processing, or mining. (1) (7)
 - Production of personal property for sale by farming, agriculture, horticulture, or floriculture. (2)
 - Production of crude oil or natural gas. (3)
 - The preparation of eggs for sale.
- A sale to a person engaged in manufacturing, assembling, processing, refining or the preparation of eggs for sale, of handling and transportation equipment, other than motor vehicles licensed to operate on public highways, for use in:
 - Intraplant transfers of personal property in the process of production for sale, or of eggs in the process of preparation for sale;
 - Shipment between plants operated by the same person of personal property in the process of production for sale, or of eggs in the process of preparation for sale.
- A sale, to a person engaged in farming, agriculture, horticulture, or floriculture of tangible personal property for use or consumption: (2)
 - Directly in the production of articles for use or consumption directly in the production of other personal property for sale.
 - In conditioning or holding of products produced for sale, or in conditioning or holding of articles produced for use or consumption directly in the production of other personal property for sale.
 - As a material or part for incorporation into articles to be produced for use or consumption directly in production of other personal property for sale.
- A sale of emergency or fire protection vehicles or equipment to a nonprofit organization for use solely in providing fire protection and emergency service for a political subdivision of the state.
- A sale to the holder of an air or noise pollution control certificate of tangible personal property to be incorporated as a material or part into an air or noise pollution control facility.
- A sale to the holder of an industrial water pollution control certificate of tangible personal property to be incorporated as a material or part into an industrial water pollution control facility.
- A sale to the holder of an energy conversion, thermal efficiency improvement, or solid waste energy conversion certificate of tangible personal property to be incorporated as a material or part into an industrial or commercial energy conversion, thermal efficiency improvement, or solid waste energy conversion facility.
- A sale of tangible personal property manufactured in this state and sold by the manufacturer to a retailer for use in his retail business outside of this state and with possession taken by the retailer from the manufacturer within this state for the sole purpose of immediately removing the property from this state in a vehicle owned by the purchaser. Interstate Commerce.
- Sales to a person licensed to conduct food service operation under section 3732.03 of the Revised Code and Chapter 3701-21 of the Administrative Code of tangible personal property directly used in preserving, preparing, or serving food for human consumption, or directly in maintaining or cleaning such property.
