

## OFFICIAL RULES

### OPEN TO RESIDENTS OF THE STATE OF OHIO 18 YEARS AND OLDER ONLY

- 1. How to Enter:** Purchase Cooper Lighting products on an account established with Wolff Bros. Supply, Inc. (“Sponsor”) that are invoiced by Sponsor during the Promotion Period, where orders of stock material are weighted at 100% and special orders are weighted at 50% (“Qualifying Purchases”).
